Number portability allows customers to keep their numbers when switching from one service provider to another.

The draft Regulations therefore seek to ensure, among others, effective functionality of number portability and that number portability occurs in an efficient manner without delays or disruption of services.

Presentations are limited to stakeholders who submitted written comments. However, interested stakeholders and members of the public are also invited to attend the public hearings.
