
## MACHINE RELATED SERVICE MIGRATION

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice for the request of Machine Related Service Migration reports.
2. In terms of Government Notice No. 40723 dated 27 March 2017 the deadline for completion of the Machine Related Service migration is prescribed as 28 September 2018.
3. In order to ensure the timeous completion of the migration, the Authority requests all licensees (as defined in the Numbering Plan Regulations Government Gazette 39861) to submit progress reports on the status and progress of the migration.
4. The abovementioned reports are requested in line with section 4(3)(g) of the Independent Communications Authority of South Africa Act No. 13 of 2000 read with regulation 9(1)(a) of the Regulations on Standard Terms and Conditions for Individual Licensees.
5. Reports shall be confined to the following format:

Previously assigned Number\Ing range	Description of service	New assigned Number\ Ing range	Date of activation of newly assigned number	Date of deactivation of previously assigned number	Comments on migration


6. Reports shall be due no later than 16:00 on the following dates:

- a. 31 May 2018;
- b. 20 July 2018; and
- c. 7 September 2018
