**NOTICE OF NOMINATIONS OF MEMBERS TO SERVE ON THE SOUTH AFRICAN DENTAL TECHNICIANS COUNCIL
IN TERMS OF THE DENTAL TECHNICIANS ACT, 1979 (ACT NO. 19 OF 1979), AS AMENDED**

The South African Dental Technicians Council (SADTC) is a regulatory authority for the dental technician's profession. The Honourable Minister of Health, Dr Aaron Motsoaledi, hereby invites the public and institutions to submit nominations of suitable candidates to be considered for appointment to the SADTC in terms of Section 5 (1) (b) of the Dental Technicians Act, 1979 (Act No. 19 of 1979), as amended (hereinafter referred to as "the Act"), for a five-year term of office, effective from **01 September 2018** as follows:

- i. One (1) Dentist attached to a university having a dental faculty;
- ii. One (1) Dental Technician or Dental Technologist attached to an institution at which dental technicians or dental technologists are educated and trained; and
- iii. Three (3) members of the public who are not registered in terms of the Act or the Health Professions Act 56 of 1974 as amended, of whom at least one shall be appointed on account of his or her knowledge of the law.

Requirements of a valid nomination: Written nominations must contain the full name and address of the institution and/or individual making the nomination, the nominee's signed acceptance of the nomination and his/her detailed Curriculum Vitae, providing at least the following information: • Full name, ID number and gender • Contact address, telephone and fax numbers, e-mail address • Qualifications and Experience • Certified copies of academic qualifications and identity document must be attached. Kindly refer to section 6 of the Act for conditions under which a person may be disqualified from membership of the SADTC.

Nominations must be addressed to the Director-General, Department of Health (marked for the attention of the Director: Public Entities Governance).
