1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received three (3) applications for the renewal of Individual Commercial Sound Broadcasting Service Licences lodged in terms of Regulation 10 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 as amended read with section 11 of the Electronic Communications Act No. 36 of 2005 as amended ("the EC Act"). Particulars of the applications are contained in the schedule below.
2. In terms of section 11(3) read with section 9(2)a of the EC Act, the Authority is required to give notice of the applications in the Government Gazette and invite interested persons to submit written representations in relation to the applications.
3. The applications, relevant schedule and any representations received pursuant thereto will be made available and be open for inspection by interested parties in the Authority's library during the Authority's office hours.
4. Interested parties are invited to lodge written representations in relation to the applications within fourteen (14) working days of the date of publication of this notice in the *Government Gazette*.
5. Any person who makes written representations must indicate whether they wish to make oral submissions should the Authority decide to hold a public hearing in respect of the application. 6. Any person who lodges representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been sent by registered mail or by facsimile, or delivered to the persons mentioned in the schedule below.
7. The Applicants shall be entitled to respond in writing to written representations made by interested persons. The written responses must be lodged with the Authority within twenty-one (21) working days after receipt of the written representations. The Applicants must, at the time of lodging the written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by email to the relevant person(s) having made such written representations.
