ANNOUNCEMENT AND INVITATION TO SUBMIT PROPOSALS FOR THE REVIEW OF THE 2002 NATIONAL COMMERCIAL PORTS POLICY AND THE NATIONAL PORTS ACT 12 OF 2005

The Comprehensive Maritime Transport Policy (CMTP) whilst acknowledging the 2002 National Commercial Ports Policy as the current policy on the operation and regulation of the South African ports system, it however resolved to review and update the White Paper taking into account developing trends and challenges.

The Department of Transport invites maritime stakeholders and interested parties to submit proposals to review the 2002 White Paper on National Commercial Ports Policy and as well as the National Ports Act 12 of 2005. Written submissions of areas proposed to be reviewed must contain the following information

- (a) Section or area to be reviewed
- (b) The actual review text
- (c) Motivation for the proposed review; and
- (d) Desired impact of the proposed review.

Both the White Paper on National Commercial Ports Policy, 2002 and the National Ports Act 12 of 2005 are freely available from the website of the Department of Transport on www.transport.gov.za
