**AMENDMENT OF NOTICE OF COMMENCEMENT OF FINANCIAL SECTOR  
REGULATION ACT, 2017**

In terms of section 305 of the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017), I, Nhlanhla Musa Nene, Minister of Finance, hereby amend General Notice No. 169 of 29 March 2018 ("the Notice") in—

- (a) paragraph (b) of the Notice, by the substitution for the expression "Chapter 13 (sections 167 to 173)" of the expression "Chapter 13 (sections 167 to 174)"; and
- (b) paragraph (h) of the Notice—
  - (i) by the substitution in the first column of the table for the expression "Friendly Society Act, 1956 (Act No. 26 of 1956)", of the expression "Friendly Society Act, 1956 (Act No. 25 of 1956)";
  - (ii) by the substitution in the first column of the table for the expression "South African Reserve Bank Act, 1990 (Act No. 89 of 1990)", of the expression "South African Reserve Bank Act, 1989 (Act No. 90 of 1989)"; and
  - (iii) in respect of the Co-operative Banks Act, 2007 (Act No. 40 of 2007) referred to in the first column of the table and Item 7 (Chapter VIIA (sections 40A to 40F)) referred to in the second column of the table, by the substitution in the third column of the table for the expression "1 October 2018" of the expression "1 August 2018".
