**NOTICE FOR WORKSHOPS TO BE HELD WITHIN THE DECLARED SUTHERLAND CENTRAL ASTRONOMY ADVANTAGE AREA TO PROVIDE SPECIAL ASSISTANCE**

I, Mere Kgampe, Director of the Astronomy Management Authority established within the Department of Science and Technology and assigned to be the management authority for the declared Sutherland Central Astronomy Advantage Area in terms of section 15 of the Astronomy Geographic Advantage Act, 2007 (Act No.21 of 2007), by the Minister of Science and Technology, hereby, in terms of Regulation 5 of the Regulations on fair administrative procedures published in terms of the Promotion of Administrative Justice Act, 2000, give notice of workshops that will be held within the Sutherland Central Astronomy Advantage Area.

The Minister's intention to make regulations and to prohibit certain mining activities for the protection of the Sutherland Central Astronomy Advantage Area was published in Notices 745 and 746 of 2018, in Government Gazette number 41793 on 25 July 2018. The Notices, inter alia, invited interested or affected persons and members of the public to submit written representations on or objections to the draft regulations and the prohibition contained in the Schedules to the Notices.

The purpose of the workshops is to provide special assistance to members of communities within the Sutherland Central Astronomy Advantage Area who need special assistance in order to make informed written representations. Members of the public, including interested and affected parties are invited to attend the workshops, which will be convened as follows:


Die Minister se voorneme om regulasies te maak en 'n verbod te plaas op sekere mynbedrywighede vir die beskerming van die Sutherland Sentrale Astronomievoordeelgebied, is in Kennisgewings 745 en 746 van 2018, in Staatskoerant nommer 41793 op 25 Julie 2015 gepubliseer. Die Kennisgewings het, onder andere, belanghebbende en geaffekteerde persone en lede van die publiek uitgenooi om geskrewe voorleggings of besware teen die konsep regulasies en die verbod in die Skedules tot die Kennisgewings ingesluit, in te dien.

Die doel van die werkwinkels is om spesiale ondersteuning te verskaf aan lede van die gemeenskappe binne die Sutherland Sentrale Astronomievoordeelgebied, wat spesiale ondersteuning benodig om ingeligte geskrewe voorleggings te maak.
