## A NOTICE TO ALL REGISTERED SOCIAL WORKERS

Dear Colleagues

INVITATION FOR THE NOMINATION AND ELECTION OF 1 MEMBER TO SERVE ON THE SOUTH AFRICAN COUNCIL FOR SOCIAL **SERVICE PROFESSIONS (SACSSP) IN LINE WITH SECTION 5(1)** (a).

- 1. A bonafide member of Council has submitted her resignation in writing in line with Chapter1, section 6(1)(g)(i).
- 2. The tenure of office for the 4th SA Council for Social Service Professions (SACSSP) ends in June 2021. In line with the provisions of the SSP Act no 110 of 1978, Section 16, regulation 5 (2) read together with chapter 1, Section 6(2) states that:

"if a member vacates his or her office prior to the expiry of the term of office of the members of the council, the notice referred to in sub-regulation 5(1) shall be published in the Gazette as soon as possible after the date on which such a member vacates his or her office";

#### and regulation 6(2), states that:

"every vacancy on the Council shall be filled in the same manner in which the member who vacates office was elected or appointed, as the case may be, and every member so elected or appointed shall hold the office for the unexpired portion of the period for which the member whose office became vacant was elected or appointed".

3. Registered Social workers are invited in terms of Regulations relating to the election of members of the SA Council for Social Service Professions , section 16 (1)-(15) to nominate one (1)preferred practitioner to serve on Council in line with regulation 6.
