PROCLAMATION NO. 34 OF 2018

**AMENDMENTS OF THE TERMS OF REFERENCE OF THE COMMISSION OF
INQUIRY INTO ALLEGATIONS OF STATE CAPTURE, CORRUPTION AND
FRAUD IN THE PUBLIC SECTOR INCLUDING ORGANS OF STATE**

Under the powers vested in me by section 1 of the Commissions Act, 1947 (Act No. 8 of 1947), I, with effect from 29 November 2018, amend the Terms of Reference of the Commission of Inquiry into allegations of state capture, corruption and fraud in the Public Sector including organs of State appointed in terms of Proclamation No. 3 of 2018 published in the Government Gazette No. 41403 of 25 January 2018 as indicated in the Schedule hereto.

Definition

1. In this Proclamation "Terms of Reference" means the terms of reference published under Proclamation No. 3 published in the Government Gazette No. 41403 of 25 January 2018.

Amendment of the Terms of Reference

2. The Terms of Reference is hereby amended by the substitution of paragraph five (5) of the following paragraph:

"5. The Commission shall submit its report and recommendations to the President within **[180 days]** a period of 24 months calculated from 1 March 2018."
