NOTICE ON THE PUBLIC HEARINGS ON ESKOM'S THIRD MULTI-YEAR PRICE DETERMINATION REGULATORY CLEARING ACCOUNT YEAR 5 (2017/18) AND FOURTH MULTI-YEAR PRICE DETERMINATION APPLICATIONS

The National Energy Regulator of South Africa (NERSA or 'the Energy Regulator') is a regulatory authority established as a juristic person in terms of Section 3 of the National Energy Regulator Act, 2004 (Act No. 40 of 2004). NERSA's mandate is to regulate the electricity, piped-gas and petroleum pipelines industries in terms of the Electricity Regulation Act, 2006 (Act No. 4 of 2006), Gas Act, 2001 (Act No. 48 of 2001) and Petroleum Pipelines Act, 2003 (Act No. 60 of 2003).

NERSA received Eskom's Third Multi-Year Price Determination (MYPD3) Regulatory Clearing Account (RCA) Year 5 (2017/18) application totalling R21 624m on 12 September 2018, and MYPD4 application totalling R219bn, R252bn and R291bn for 2019/20, 2020/21 and 2021/22 financial years respectively, on 14 September 2018 (available on the NERSA website www.nersa.org.za and on request).

The Energy Regulator invites the public and all stakeholders to attend the scheduled public hearings on Eskom's applications. The public hearings will be conducted in all the provinces as indicated in the schedule below:
