I, Nomvula Paula Mokonyane, Minister of Environmental Affairs, hereby under section 14 of the World Heritage Convention Act, 1999 (Act No. 49 of 1999) read with regulations 18(2)(a) of the Regulations on Fair Administrative Procedures, 2002 give notice of my intention to establish a Board for Isimangaliso Wetland Park.

- certified copies of both academic qualifications and identity document;
- experience with reference to the criteria contained in section 14(4) of the World Heritage Convention Act, 1999 (Act No. 49 of 1999); and
