1. Notice is hereby given in terms of section 24(2)(b) of the Legal Aid South Africa Act, 2014 (Act No. 39 of 2014) that the Minister of Justice and Correctional Services has tabled amendments to the Legal Aid Manual in Parliament.
2. In terms of section 24(3) of the Legal Aid South Africa Act, 2014, the amendments to the Legal Aid Manual take effect 60 days after publication of this notice.
3. Paragraphs 4.4.1, 4.4.2 and 4.5, as well as Annexures B and C of the Legal Aid Manual are amended. The amendments relate to the allocation of instructions to Judicare practitioners in accordance with Legal Aid South Africa's Judicare Accreditation System, as well as to the tariffs and fees payable to Judicare practitioners. Certain naming conventions, wherever they appear in the Legal Aid Manual, are also amended.

3. Paragrafe 4.4.1, 4.4.2 en 4.5, asook Bylae B en C van die Regshulphandleiding word gewysig. Die wysigings het betrekking op die toekenning van instruksies aan Judicare praktisyns ingevolge Regshulp Suid-Afrika se Judicare Akkreditasie Stelsel, asook op die tariewe en foie betaalbaar aan Judicare praktisyns. Sekere benamingskonvensies, waar dit in die Regshulphandleiding verskyn, word ook gewysig.
