REPUBLIC OF SOUTH AFRICA**NOTICE OF NOMINATIONS OF MEMBERS TO SERVE ON THE SOUTH AFRICAN DENTAL TECHNICIANS COUNCIL IN TERMS OF THE DENTAL TECHNICIANS ACT, 1979 (ACT NO. 19 OF 1979), AS AMENDED**

The South African Dental Technicians Council (SADTC) is established in terms of the Dental Technicians Act, 1979 (Act No. 19 of 1979) as amended (hereinafter referred to as "the Act"), to regulate the professions of dental technicians and dental technologists, and to protect the interests of the public. The Honourable Minister of Health, Dr ZL MKhize, hereby invites the public and institutions to submit nominations of suitable candidates to be considered for appointment to the SADTC in terms of Section 5 (1) (b) of the Act for a five-year term of office, effective from **01 March 2020** as follows:

- i. One (1) Dentist attached to a university having a dental faculty.
- ii. One (1) Dental Technician or Dental Technologist attached to an institution at which dental technicians or dental technologists are educated and trained.
- iii. Three (3) members of the public who are not registered in terms of the Act or the Health Professions Act 56 of 1974 as amended, of whom at least one shall be appointed on account of his or her knowledge of the law.

Requirements of a valid nomination: Written nominations must contain the full name and address of the institution and/or individual making the nomination, the nominee's signed acceptance of the nomination and his/her detailed Curriculum Vitae, providing at least the following information: • Full name, ID number and gender • Contact address, telephone and fax numbers, e-mail address • Qualifications and Experience • Certified copies of academic qualifications and identity document must be attached. Kindly refer to section 6 of the Act for conditions under which a person may be disqualified from membership of the SADTC.

Nominations must be addressed to the Director-General, Department of Health (marked for the attention of the Director: Public Entities Governance). Nominations may be hand delivered at the Department of Health, Civitas Building, Corner of Thabo Sehume (Formerly known as Andries) and Struben Streets, Pretoria; or posted to Private Bag X828, Pretoria, 0001 and/or emailed to Paul.Tsebe@health.gov.za Telephonic enquiries may be directed to: Mr. P. Closing date for nominations: Friday, 29 November 2019 at 16:00. Please note that nominees may be subjected to a qualifications check and security clearance. Nominees are respectfully informed that correspondence will be limited to the successful candidates. Late submissions will not be considered.
