EMPOWERMENT ADVISORY COUNCIL**

On behalf of the President of the Republic of South Africa I, Ebrahim Patel, Minister of Trade and Industry, hereby call for nominations for Members to serve on the Broad-Based Black Economic Empowerment Advisory Council (B-BBEEAC).

The Broad-Based Black Economic Empowerment Advisory Council is established in terms of Section 4 of the Broad-Based Black Economic Empowerment Act, 53 of 2003 as amended by Act 46 of 2013 ('the Act').

The B-BBEEAC is required to:

- advise government on black economic empowerment;
- review progress in achieving black economic empowerment;
- advise on draft codes of good practice which the Minister intends publishing for comment in terms of the Act;
- advise on the development, amendment or replacement of the strategy referred to in section 11 of the Act;
- if requested to do so, advise on draft transformation charters; and
- facilitate partnerships between organs of state and the private sector that will advance the objectives of this Act.

Business Associations, Trade Unions, civil society groups and individuals are invited to nominate persons to become Members of the Council for a five-year period. Nominations should set out the appropriate expertise of the nominee and how she/he will contribute to representivity of different constituencies, including trade unions, business, community-based organisations and academics.

Nominations must include the Curriculum Vitae of the nominee and a letter of consent indicating the availability of the nominee to serve on the B-BBEEAC. Self-nominations will not be considered. Where possible, letters of reference for the nominee should be included.

Nominations must be forwarded within four weeks of publication of this notice, to: Human Resources, Department of Trade and Industry, Private Bag X84, Pretoria, 0001 or email to [applications@thedti.gov.za](mailto:applications@thedti.gov.za).
