The Advisory Committee (High-Level Panel) was appointed under section 3A of the National Environmental Management Act, 1998 (Act No. 107 of 1998), through the publication of Notice No. 1317 in Government *Gazette* No. 42761 on 10 October 2019, to review existing policies, legislation and practices relating to the management and handling, breeding, hunting and trade of elephant, lion, leopard and rhinoceros, as contemplated in the National Environmental Management: Biodiversity Act, 2004 (Act No. 10 of 2004).

On 27 March 2020, through the publication of Notice No. 221 in Government *Gazette* No. 43173, the High-Level Panel invited members of the public to submit written submissions, scientific information, socio-economic information or any other relevant information on matters related to the handling and management, breeding, hunting and trade of elephant, lion, leopard and rhinoceros. Submissions or information had to be submitted within 60 days of publication of Notice No. 221. The High-Level Panel herewith extends the date for the provision of such submissions and information to 15 June 2020.
