ON THE GAUTRAIN MANAGEMENT AGENCY BOARD**

Gautrain Management Agency (GMA) is a Provincial Public Entity listed in schedule 3 (c) of the Public Finance Management Act. The GMA is established in terms of the GMA Act No. 5 of 2006 as amended, to manage, coordinate and oversee concession agreements for the Gauteng rail transit system and assist the Province and other Organs of State in realising their integrated public transport and rail-related objectives in the Province.

The Member of the Executive Council for Gauteng Department of Public Transport and Roads Infrastructure would like to invite suitable candidates or interested parties to nominate suitable candidates to serve as members of the GMA Board.

REQUIREMENTS FOR NOMINATIONS AND APPLICATIONS: Candidates should have leadership qualities and be committed to the primary objects and mandates of the GMA. The functional competencies needed in the GMA Board have been developed in line with Section 10 (1) (a) of the GMA Amendment Act and the GMA's evolving strategy. These are Transport Planning, Rail Engineering and Management, Public Private Partnerships and Corporate Finance, Information Technology Governance, Finance and Risk Management, Legal and Compliance, Human Resource Management, Marketing, Socio-economic development, B-BBEE and Transformation.

In addition to the above competencies, three (3) or more years Board experience in the Public or Private Sector during the five (5) years prior to this application, experience in corporate governance, as well as, personal and social competencies required of a Board Member, will be an added advantage.

DISQUALIFICATIONS FOR APPOINTMENT: Section 11(1) of the GMA Amendment Act stipulates the following criteria to determine eligibility for appointment to the GMA Board:

A candidate may not be appointed as a Member of the GMA Board if that candidate:

- a) is not a citizen of the Republic, and resident in the Gauteng Province;
- b) is an unrehabilitated insolvent;
- c) is a Member of Parliament, a Provincial Legislature, a Municipal Council or a House of Traditional Leaders established in terms of the Constitution;
- d) is of unsound mind, as declared by a competent court;
- e) has at any time been convicted of an offence involving dishonesty;
- f) has at any time been removed from office of trust on account of misconduct; and
- g) has previously been removed from the Board for a breach of any provision of the GMA Act.

TERMS AND CONDITIONS: The term of office for Members of the Board is three (3) years. A Member whose term of office has expired is eligible for reappointment provided that such a Member may not serve for more than two (2) consecutive terms. Remuneration for Members of the Board is in line with the rates prescribed by the National Treasury.

SUPPORTING DOCUMENTS: Candidates are required to submit the following documents:

- a) Full CV including Board experience;
- b) Copies of qualifications certified in the last 3 months;
- c) Copy of the ID certified in the last three months;
- d) Copy of the relevant professional certificates certified in the last three months; and
- e) Two reference letters.
