Notice is hereby given in terms of Section 62(1)(a) of the Legal Practice Act No.28 of 2014 and amended Rule 46.5.2 to every practising attorney and advocate, calling for nominations of practising attorneys and advocates for the elections to the Legal Practitioners Fidelity Fund (LPFF) Board.

Practitioners are required to nominate candidates eligible in terms of Rule 46.1 and Rule 46.2 to stand for election to the LPFF Board.

The geographic regions indicated in Rule 46.1 are based on the regions that a practitioner's principal place of business falls into. For the purpose of this election these regions are grouped as follows:

- Gauteng Division of the High Court of South Africa
- Western Cape and Northern Cape Divisions of the High Court of South Africa
- Free State, Mpumalanga, North West and Limpopo Divisions of the High Court of South Africa
- KwaZulu Natal Division and Eastern Cape Divisions of the High Court of South Africa

With reference to Rule 46.2, candidates may be nominated from among practising Advocates referred to in Section 34(2)(b) who are in good standing, by all the practising legal practitioners in the Republic who are in good standing. The list of advocates for this category is on Council website www.lpc.org.za – LPFF Board Elections 2020

Nominations may be made on The Electronic Nominations Platform.

Legal practitioners may opt to submit their nominations by downloading the nomination and acceptance forms from the LPC website www.lpc.org.za

ALL FORMS MUST BE SIGNED BY THE NOMINATOR AND ACCEPTED BY NOMINEE – any form which is submitted unsigned is invalid.
