

Under sections 59A, 60 and 120 of the Customs and Excise Act, 1964 (Act No. 91 of 1964), the rules published in Government Notice R.1874 of 8 December 1995, are herewith amended to the extent set out in the Schedule hereto.

1. Rule 59A.01A is hereby amended –
 - (a) by the substitution in paragraph (c)(ii)(bb) –
 - (i) for the expression “60 days” of the expression “60 calendar days”; and
 - (ii) for the expression “20 April 2020” of the expression “24 April 2020”; and
 - (b) by the substitution in paragraph (c)(iii)(B) for the expression “60 days” of the expression “60 calendar days”.

The amendments effected in this Schedule come into effect on the date of publication save for paragraph (a)(ii) of item 1 and paragraph (a)(ii) of item 2 which are regarded to have come into effect on 24 April 2020.
