**NATIONAL TREASURY****NOTICE 578 OF 2020****INTENTION TO INTRODUCE DIVISION OF REVENUE SECOND AMENDMENT BILL FOR 2020/21 FINANCIAL YEAR IN PARLIAMENT AND PUBLICATION OF ITS EXPLANATORY SUMMARY**

In terms of rule 276(1)(b) and (c) of the Rules of the National Assembly—

- (a) notice is given of the introduction by the Minister of Finance of the Division of Revenue Second Amendment Bill (“the Bill”) in the National Assembly; and
- (b) the following explanatory summary of the Bill is published:

The Bill proposes to amend the Division of Revenue Act, 2020 (Act No. 4 of 2020), as amended by the Division of Revenue Amendment Act, 2020 (Act No.10 of 2020), in accordance with section 12(4) of the Money Bills and Related Matters Act, 2009 (Act No. 9 of 2009). This is necessary because the second national adjustments budget for the 2020/21 financial year necessitates changes to the Division of Revenue Act, 2020, as amended. The Bill is to be introduced together with the tabling of the second national adjustments budget and a revised fiscal framework for the 2020/21 financial year.

- (b) die volgende verduidelikende opsomming van die Wetsontwerp hierby gepubliseer:

Die Wetsontwerp stel voor om die “Division of Revenue Act, 2020 (Act No. 4 of 2020), soos deur die “Division of Revenue Amendment Act, 2020 (Act No.10 of 2020)” gewysig, ingevolge artikel 12(4) van die “Money Bills and Related Matters Act, 2009 (Act No. 9 of 2009)” te wysig. Dit is nodig omdat die tweede nasionale aansyweringsbegroting vir die 2020/21 finansiële jaar veranderinge aan die “Division of Revenue Act, 2020”, soos gewysig, vereis. Die Wetsontwerp moet saam die tertaaflegging van die tweede nasionale aansyweringsbegroting en ’n gewysigde fiskale raamwerk vir die 2020/21 finansiële jaar ingedien word.
