**Invitation for public hearings on Eskom's third Multi-Year Price Determination (MYPD3) Regulatory Clearing Account (RCA) Year 2 (2014/15), Year 3 (2015/16) and Year 4 (2016/17) applications, Eskom's Supplementary application and the implementation plan for liquidation of the 2018/19 RCA balance**

The National Energy Regulator of South Africa (NERSA) is a regulatory authority established as a juristic person in terms of Section 3 of the National Energy Regulator Act, 2004 (Act No. 40 of 2004). NERSA's mandate is to regulate the electricity, piped-gas and petroleum pipelines industries in terms of the Electricity Regulation Act, 2006 (Act No. 4 of 2006), Gas Act, 2001 (Act No. 48 of 2001) and Petroleum Pipelines Act, 2003 (Act No. 60 of 2003).

On 1 October 2020, the Energy Regulator published consultation papers on the three topics mentioned below together with the timelines for approval. These documents are available on NERSA website [www.nersa.org.za](http://www.nersa.org.za).

NERSA invites all stakeholders to attend public hearings on the three topic provided below:

1. Eskom's third Multi-Year Price Determination (MYPD3) Regulatory Clearing Account (RCA) Year 2 (2014/15), Year 3 (2015/16) and Year 4 (2016/17) applications;
2. Eskom's Supplementary application; and
3. The implementation plan for liquidation of the 2018/19 RCA balance
