**AMENDMENT OF REGULATIONS RELATING TO ASSISTANCE TO VICTIMS IN  
RESPECT OF BASIC EDUCATION: PROMOTION OF NATIONAL UNITY AND  
RECONCILIATION ACT, 1995**

The President has, under section 27(2) of the Promotion of National Unity and Reconciliation Act, 1995 (Act No. 34 of 1995), made the Regulations in the Schedule.

**SCHEDULE****Definitions**

1. In this Schedule “the Regulations” means the Regulations published by Government Notice No. R. 853 of 3 November 2014 as amended by Government Notice No. R. 1286 of 4 October 2019.

**Amendment of regulation 1 of the Regulations**

2. Regulation 1 of the Regulations is hereby amended by the insertion of the following definition after the definition of “beneficiary”:

“**COVID-19**” for the purposes of regulation 15A means the Novel Coronavirus (2019-nCov2) which is an infectious disease caused by a virus that has previously not been scientifically identified in humans, which emerged during 2019 and was declared a global pandemic by the World Health Organisation in 2020;”.

**Amendment of regulation 5 of the Regulations**

3. Regulation 5 of the Regulations is hereby amended by—
- (a) the substitution for paragraph (c) of subregulation (1) of the following paragraph:  
“(c) payment of a school uniform allowance of R3 637,00 per annum;  
and”;
  - (b) the substitution for paragraph (d) of subregulation (1) of the following paragraph:  
“(d) payment of a transport allowance of R4 407,00 per annum despite the fact that a learner could not attend school the whole year due to COVID-19: Provided that any part of the allowance not used for attending school must be used for any education related expenses incurred by a learner.”; and
  - (c) the deletion of subregulations (3) and (5).

**Amendment of regulation 6 of the Regulations**

4. Regulation 6 of the Regulations is hereby amended by—
- (a) the substitution for paragraph (c) of subregulation (1) of the following paragraph:  
“(c) payment of a school uniform allowance of R3 637,00 per annum;  
and”;
  - (b) the substitution for paragraph (d) of subregulation (1) of the following paragraph:

- “(d) payment of a transport allowance of R4 407,00 per annum despite the fact that a learner could not attend school the whole year due to COVID-19: Provided that any part of the allowance not used for attending school must be used for any education related expenses incurred by a learner.”; and
- (c) the deletion of subregulations (2) and (4).

#### **Amendment of regulation 7 of the Regulations**

5. Regulation 7 of the Regulations is hereby amended by—
- (a) the substitution for paragraph (c) of subregulation (1) of the following paragraph:
    - “(c) payment of a school uniform allowance of R4 407,00 per annum; and;”;
  - (b) the substitution for paragraph (d) of subregulation (1) of the following paragraph:
    - “(d) payment of a transport allowance of R5 143,00 per annum despite the fact that a learner could not attend school the whole year due to COVID-19: Provided that any part of the allowance not used for attending school must be used for any education related expenses incurred by a learner.”; and
  - (c) the deletion of subregulations (2) and (4).

#### **Amendment of regulation 10 of the Regulations**

6. Regulation 10 of the Regulations is hereby amended by—
- (a) the substitution for paragraph (a) of subregulation (3) of the following paragraph:
    - “(a) An application for assistance must be submitted to the dedicated official on or before the cut-off date provided for in paragraph (b).”; and
  - (b) the substitution for paragraph (b) of subregulation (3) of the following paragraph:
    - “(b) the cut-off date for the submission of applications for assistance is 30 September of every year for applications for the subsequent year.”.

#### **Amendment of regulation 11 of the Regulations**

7. Regulation 11 of the Regulations is hereby amended by—
- (a) the substitution for paragraph (a) of subregulation (2) of the following paragraph:
    - “(a) A victim or a relative or dependant of a victim who received assistance in terms of these Regulations for a particular year and who wishes to receive further assistance in subsequent years to complete his or her school education, does not have to re-apply for further assistance but must complete Form 3 in the Annexure and submit it to the dedicated official in the manner provided for in regulation 10(8) on or before the cut-off date provided for in regulation 10(3)(b).”; and
  - (b) the addition in subregulation (2) of the following paragraph after paragraph (c):
    - “(d) The procedures set out in regulations 13 and 14 are applicable in respect of any subsequent application for assistance.”.

**Amendment of regulation 13 of the Regulations**

8. Regulation 13 of the Regulations is hereby amended by the deletion of subregulation (2).

**Amendment of regulation 15 of the Regulations**

9. Regulation 15 of the Regulations is hereby amended by—
- (a) the deletion of paragraph (a) of subregulation (5); and
  - (b) the deletion of the expression “or a school uniform allowance” after the words “boarding allowance” in paragraph (c) of subregulation (5).

**Insertion of regulation 15A in the Regulations**

10. The following regulation is hereby inserted in the Regulations after regulation 15:

**“Extension of assistance due to COVID-19**

**15A.** (1) The administrator may, if the 2020 school year is extended to 2021 as a result of COVID-19, with the approval of the fund administrator, provide to beneficiaries, for the period for which the 2020 school year is extended, the forms of assistance contemplated in these Regulations.

(2) The amount of assistance to be paid per month or part thereof by the administrator in respect of any form of assistance in terms of subregulation (1) must be determined by the administrator, in consultation with the fund administrator, by dividing the amounts determined in these Regulations by 11.”.

**Amendment of regulation 16 of the Regulations**

11. Subregulations (1), (2) and (3) of Regulation 16 are hereby substituted by the following subregulations:

“(1) Subject to subregulation (3), the fund administrator must, for purposes of the payments to be made in terms of regulations 15 and 15A, make regular advance payments to the Department.

(2) (a) The fund administrator must make the first advance payment referred to in subregulation (1), which may not be less than 25% of the amount determined in terms of regulation 4, not later than 15 January 2021.

(b) The fund administrator must make, within one month after the publication of these Regulations in the *Gazette*, an advancement payment to the Department, which may not be less than 50% of the amount determined in terms of regulation 4 for 2020.

(3) The Department must, despite any advance payment received from the fund administrator, submit to the fund administrator as soon as is reasonably possible proof of payments made to beneficiaries.”.

**Amendment of regulation 17 of the Regulations**

12. Regulation 17 of the Regulations is hereby amended by the substitution for paragraph (e) of subregulation (2) of the following paragraph:

“(e) the decision made by the dedicated official in respect of the verification of the status in terms of regulation 12.”

### Amendment of regulation 21 of the Regulations

**13.** Subregulation (1) of regulation 21 of the Regulations is hereby amended by the substitution for the expression “six years” for the expression “seven years”.

**WYSIGING VAN REGULASIES BETREFFENDE BYSTAND AAN SLAGOFFERS TEN OPSIGTE VAN BASIESE ONDERWYS: WET OP BEVORDERING VAN NASIONALE EENHEID EN VERSOENING, 1995**

Die President het, kragtens artikel 27(2) van die Wet op Bevordering van Nasionale Eenheid en Versoening, 1995 (Wet No. 34 van 1995), die Regulasies in die Bylae gemaak.

**BYLAE****Woordskrywings**

2. In hierdie Bylae beteken “die Regulasies” die Regulasies afgekondig by Goewermentskennisgewing No. R. 853 van 3 November 2014 soos gewysig deur Goewermentskennisgewing No. R. 1286 van 4 Oktober 2019.

**Wysiging van regulasie 1 van die Regulasies**

2. Regulasie 1 van die Regulasies word hierby gewysig deur die invoeging van die volgende woordskrywing na die woordskrywing van “bystand”:

“**COVID-19**” vir doeleindes van regulasie 15A, die “Novel Coronavirus (2019-nCov2)” wat ‘n aansteeklike siekte is, veroorsaak deur ‘n virus wat voorheen nie wetenskaplik in mense geïdentifiseer is nie, wat gedurende 2019 ontstaan het en in 2020 deur die Wêreldgesondheidsorganisasie as ‘n wêreldwye pandemie verklaar is;”.

“(b) die afsnydatum vir die voorlegging van aansoeke om bystand is 30 September van elke jaar vir aansoeke vir die daaropvolgende jaar.”.

#### **Wysiging van regulasie 11 van die Regulasies**

7. Regulasie 11 van die Regulasies word hierby gewysig deur —
- (a) die vervanging van paragraaf (a) van subregulasie (2) deur die volgende paragraaf:  
“(a) ‘n Slagoffer of ‘n familielid of afhanklike van ‘n slagoffer wat bystand ingevolge hierdie Regulasies vir ‘n bepaalde jaar ontvang het en wat begerig is om bystand in daaropvolgende jare te ontvang om sy of haar skoolopleiding te voltooi, hoef nie heraanzoek vir verdere bystand te doen nie, maar moet Vorm 3 van die Bylae voltooi en aan die toegewyde beampte voorlê op die wyse waarvoor in regulasie 10(8) voorsiening gemaak word, op of voor die afsnydatum waarvoor in regulasie 10(3)(b) voorsiening gemaak word.”; en

- (b) die byvoeging in subregulasie (2) van die volgende paragraaf na paragraaf (c):  
“(d) Die prosedure in regulasies 13 en 14 uiteengesit, is op enige verdere aansoek om bystand van toepassing.”.

### **Wysiging van regulasie 13 van die Regulasies**

8. Regulasie 13 van die Regulasies word hierby gewysig deur die skraping van subregulasie (2).

### **Wysiging van regulasie 15 van die Regulasies**

9. Regulasie 15 van die Regulasies word hierby gewysig deur —  
(a) die skraping van paragraaf (a) van subregulasie (5); en  
(b) die skraping van die uitdrukking “of ‘n skooldragtoelaag” na die woorde “losiestoelaag” in paragraaf (c) van subregulasie (5).

### **Invoeging van regulasie 15A in die Regulasies**

10. Die volgende regulasie word hierby in die Regulasies ingevoeg na regulasie 15:

#### **“Verlenging van bystand as gevolg van COVID-19**

**15A.** (1) Die administrateur mag, indien die 2020 skooljaar tot 2021 verleng word as gevolg van COVID-19, met die goedkeuring van die fondsadministrateur, vir die tydperk wat die 2020 skooljaar verleng is, die vorms van bystand beoog in hierdie Regulasies aan begunstigdes voorsien.

(2) Die bedrag van bystand per maand of gedeelte daarvan betaalbaar deur die administrateur ten opsigte van enige vorm van bystand ingevolge subregulasie (1) moet deur die administrateur bepaal word, in oorleg met die fondsadministrateur, deur die bedrae in hierdie Regulasies bepaal deur 11 te deel.”.

### **Wysiging van regulasie 16 van die Regulasies**

11. Subregulasies (1), (2) en (3) van Regulasie 16 word hierby deur die volgende subregulasies vervang:

“(1) Onderhewig aan subregulasie (3), moet die fondsadministrateur, vir doeleindes van die betalings wat ingevolge regulasies 15 en 15A staan gemaak te word, gereelde vooruitbetalings aan die Departement maak.

(2) (a) Die fondsadministrateur moet die eerste vooruitbetaling na verwys in subregulasie (1), wat nie minder as 25% van die bedrag ingevolge regulasie 4 bepaal mag wees nie, nie later nie as 15 Januarie 2021 maak.

(b) Die fondsadministrateur moet binne een maand na die publikasie van hierdie Regulasies in die *Staatskoerant* ‘n vooruitbetaling aan die Departement maak, wat nie minder as 50% van die bedrag wat ingevolge regulasie 4 vir 2020 bepaal is, mag wees nie.
