**PUBLICATION OF EXPLANATORY SUMMARY OF THE CORRECTIONAL SERVICES AMENDMENT BILL, 2020**

1. Notice is hereby given in terms of Rule 276(1)(b) of the Rules of the National Assembly that the Minister of Justice and Correctional Services intends introducing the Correctional Services Amendment Bill, 2020, in the National Assembly shortly.

2. The explanatory summary of the Bill is hereby published in accordance with Rule 276(1)(c) of the Rules of the National Assembly.

The Bill aims to amend the Correctional Services Act, 1998 (Act No. 111 of 1998), so as to amend the definition of “Minister” to align it with the portfolio(s) assigned by the President from time to time. The Bill also aims to amend the Act by inserting, deleting and amending certain provisions related to the placement of sentenced offenders under day parole, parole and correctional supervision, the criteria used to determine the minimum detention period to be served before becoming eligible for consideration for placement on day parole, parole and correctional supervision and providing for matters connected therewith.

2. Die verduidelikende opsomming van die Wetsontwerp word hierby ooreenkomstig Reël 276(1)(c) van die Reëls van die Nasionale Vergadering gepubliseer.

Die Wetsontwerp het ten doel om die Korrektiewe Dienstewet, 1998 (Wet No. 111 van 1998) te wysig deur die definisie van "Minister" te wysig ooreenkomstig die portefeulje(s) toegeken deur die President van tyd tot tyd. Die Wetsontwerp het verder ten doel om sekere bepalings van die Wet te wysig aangaande die plasing van gevonnise oortreders op dagparool, parool en korrektiewe toesig, die kriteria wat oorweeg moet word om die minimum aanhoudingstydperk te bepaal alvorens 'n gevonnise oortreder oorweeg kan word vir plasing op dagparool, parool en korrektiewe toesig, en aanverwante aangeleenthede.
