AMENDMENT OF DIRECTIONS REGARDING MEASURES TO ADDRESS, PREVENT AND COMBAT THE SPREAD OF COVID-19 RELATING TO BIODIVERSITY AUCTIONS

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment hereby—

- (a) amend the Directions regarding Measures to Address, Prevent and Combat the spread of Covid-19 relating to Biodiversity Auctions published in Government Notice No. 1064 in Government Gazette No. 43778 of 07 October 2020 made in terms of regulation 4(10) of the Regulations issued by the Minister of Co-operative Governance and Traditional Affairs in terms of section 27(2) of the Disaster Management Act, 2002 (Act No. 57 of 2002) and published on 29 April 2020 in Government Notice No. R. 480 of Government Gazette No. 43258, as amended, as set out in the Schedule hereto; and
- (b) repeal the—
 - (i) Directions regarding Measures to Address, Prevent and Combat the Spread of Covid-19 relating to the Biodiversity Sector published in Government Notice No. 537 in Government Gazette No. 43323 of 14 May 2020, as amended; and
 - (ii) Directions regarding Measures to Address, Prevent and Combat the Spread of Covid-19 relating to the Biodiversity Sector published in Government Notice No. 647 in Government Gazette No. 43409 of 5 June 2020, as amended.

SCHEDULE

1. Definitions

In this Schedule, unless the context otherwise indicates-

"Directions" means the Directions regarding Measures to Address, Prevent and Combat the Spread of COVID-19 relating to Biodiversity Auctions, published in Government Notice No. 1064 in Government Gazette No. 43778 of 07 October 2020.

2. Amendment of paragraph 1 of the Directions

Paragraph 1 of the Directions is hereby amended by the substitution for the definition of "Regulations" of the following definition:

"Regulations" means the Regulations issued in terms of section 27(2) of the Disaster Management Act and published under Government Notice No. R.480 of Government Gazette No. 43258 of 29 April 2020, as amended by Government Notices Nos. R. 608 of Government Gazette No. 43364 of 28 May 2020, R. 714 of Government Gazette No. 43476 of 25 June 2020, R. 763 of Government Gazette No. 43521 of 12 July 2020, R. 846 of Government Gazette No. 43577 of 31 July 2020, R. 891 of Government Gazette No. 43620 of 17 August 2020, R.999 of Government Gazette No. 43725 of 18 September 2020, R.1011 of Government Gazette No. 43727 of 20 September 2020, R.1053 of Government Gazette No. 43763 of 01 October 2020, R.1104 of Government Gazette No. 43825 of 21 October 2020, R.1199 of Government Gazette No. 43897 of 11 November 2020, R.1290 of Government Gazette No. 43964 of 03 December 2020, R.1346 of Government Gazette No. 43997 of 15 December 2020, R.1370 of Government Gazette No. 44009 of 17 December 2020, R.1421 of Government Gazette No. 44042 of 24 December 2020, R.1423 of Government Gazette No. 44044 of 29 December 2020, R.1435 of Government Gazette No. 44051 of 29 December 2020, and R.11 of Government Gazette No. 44066 of 11 January 2021."

3. Amendment of paragraph 4 of the Directions

Paragraph 4 of the Directions is hereby amended by the substitution for item (a) of subparagraph 4.4 of the following item:

"(a) the number of persons who attend a live biodiversity auction may not exceed the maximum number of persons prescribed in the Regulations as amended from time to time;"
