ARMS: Azure, on a fess embowed to base Argent, a sun Or, between in chief two, and in base one pillar Argent. MOTTO: MMOHO RE KA KGONA

2. APPLICANT: Archibald Findlay (H4/3/4/1052)

ARMS: Per chevron Argent and Azure, in chief dexter a cross potent between two crescents and two mullets placed in saltire Sable, sinister a bantam Sable, beaked Argent, crested, jelloped, clawed and spurred Gules, and in base a scale Or. CREST: A young Olive tree, leaved and fructed Proper. WREATH AND MANTLING: Azure and Argent. MOTTO: BEATI PACIFICI. CRI DE GUERRE: SPIORAID FIONNLAIGH!

3. APPLICANT: Alexander Samuel Findlay (H4/3/4/1051)

This blazon replaces the blazon which was published under Notice of Application No.1403 dated 21 December 2018.

ARMS: Per chevron engrailed Argent and Azure, in chief dexter a cross potent between two crescents and two mullets placed in saltire Sable, sinister a bantam Sable, beaked Argent, crested, jelloped, clawed and spurred Gules, and in base a scale Or. CREST: A young Olive tree, leaved and fructed Proper. WREATH AND MANTLING: Azure and Argent. MOTTO: BEATI PACIFICI. CRI DE GUERRE: SPIORAID FIONNLAIGH!

4. APPLICANT: David John Rabbolini (H4/3/4/1055)

ARMS: Azure, three bars wavy Argent; in pale a Nguni shield throughout Or, thereupon three bars wavy Gules. CREST: upon a pile of three closed books arraswise in pale, that in the centre reversed, all bound Azure, cut Argent and garnished Or, a fructed oak tree eradicated Or. WREATH AND MANTLING: Azure and Or. MOTTO: BE IMPECCABLE

WAPEN: Kepersgewys van silwer en blou in die skildhoof regs 'n swart krukkruis, tussen twee skuinskruislings geplaaste wassenaars en twee vyfpuntige sterre, links 'n swart bantam silwer gebek, rooi gekam, geel, geklou en gespoor, en in die skidvoet 'n goue skaal. HELMTEKEN: 'n Jong olyfboompie geblaar en gevrug van natuurlike kleur. WRONG EN DEKKLEDE: Blou en silwer. WAPENSPREUK: BEATI PACIFICI. KREED: SPIORAID FIONNLAIGH!

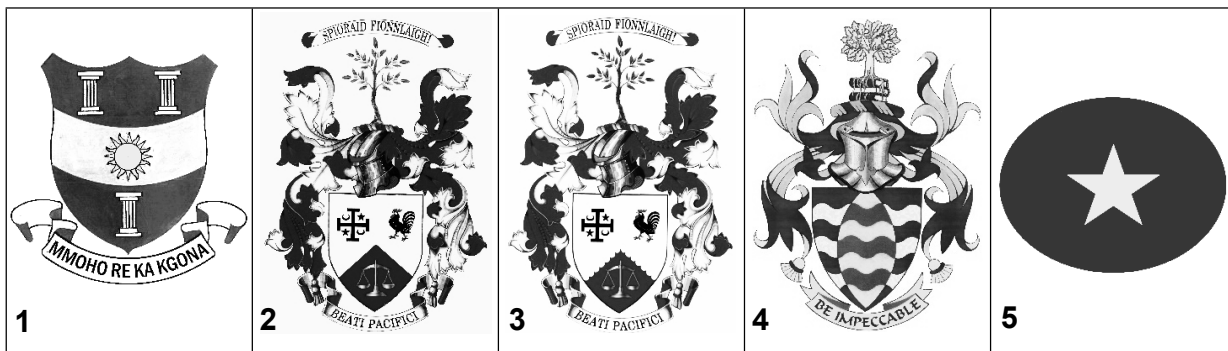
