PURSUANT TO THE DECLARATION OF 1 NOVEMBER 2021 AS A PUBLIC HOLIDAY UNDER SECTION 2A OF THE PUBLIC HOLIDAYS ACT, 1994 (ACT NO. 36 OF 1994), THE INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA HEREBY PUBLISHES A NOTICE REGARDING THE AMENDMENT OF THE CLOSING DATE FOR PUBLIC REPRESENTATIONS ON THE INFORMATION MEMORANDUM

1. On 01 October 2021, the Independent Communications Authority of South Africa (“the Authority”) published the Notice regarding the Information Memorandum on Licensing of Spectrum in the IMT700, IMT800, IMT2600 and IMT3500 Bands in Government Gazette No. 45255 (“the Information Memorandum Notice”).
2. On 12 October 2021, President Cyril Ramaphosa (“the President”) declared 01 November 2021 as a public holiday, under section 2A of the Public Holidays Act, 1994 (Act No. 36 of 1994) due to the local government elections.
3. The above declaration by the President coincides with one of the dates set out by the Authority in paragraph 12 on page 6 of the Information Memorandum Notice, which stipulates the closing date for public representations to the Information Memorandum as 01 November 2021.
4. The Authority thus hereby amends the closing date of public representations to the Information Memorandum to 02 November 2021. Interested persons are therefore to submit written representations to the Authority, including an electronic version of the representations in Microsoft Word by no later than 12h00 (midday) on **02 November 2021**.
5. All other dates and information in the IM Notice remain unchanged.
